2022 WEDDING COMPETITION RULES COTTON BIRD x CHARLOTTE HUGUET

From Thursday 6th October 2022 at 10am to Tuesday 11th October 2022 at 23.59pm Cotton Bird is hosting a competition whose rules are set out below.

ARTICLE 1 – COMPETITION ORGANISATION

Les Editions Créatives (hereinafter the « Cotton Bird"), a company registered with the trade and companies register of PERPIGNAN under the number 532 425 097 and whose head office is located at 27 Rue Gustave Eiffel, 66280 Saleilles, FRANCE, is running from **Thursday 6th October 2022 at 10am to Tuesday 11th October 2022 at 23.59pm** a competition with no purchase necessary available at the following address: https://www.cottonbird.uk/contest-weddingshow - whose terms and conditions are set out in these rules.

ARTICLE 2 - CONDITIONS OF ENTRY

This competition is open to any natural person aged over 18 with an internet connection and a valid email address living in mainland France, with the exception of employees of Cotton Bird the competition and their families or partners, and broadly speaking any company or store involved directly or indirectly with promoting and/or running the competition (hereinafter referred to as the "Entrant").

Cotton Bird reserves the right to carry out any necessary checks concerning the identity, postal and/or email address of the entrants. If any information submitted is found to be incorrect, the entry will be cancelled without the liability of Les Editions Créatives being incurred. The competition is governed by the applicable French law relating to games and competitions. Simply entering the competition entails full unreserved acceptance of these rules. Incomplete entries will not be considered. In this case, entrants cannot claim any prize. Any person who has not supplied their contact details or full identity, or who has supplied incorrect or misleading details, will be disqualified, as will any person refusing permission for their personal details to be collected, saved and used for the strict purposes of running the competition. Only one entry per Entrant (same surname, same first name, same email address) throughout the entire period of the competition is permitted. It is strictly forbidden for an entrant to enter the competition with several email addresses or to enter the competition from an account opened in another person's name. In the event of several entries made by one single entrant, their entry will be totally invalidated.

ARTICLE 3 – ACCEPTANCE OF RULES

Entering the competition implies the Entrant's unconditional acceptance of these Rules, the principle behind the competition, the Website General Terms and Conditions of Use and the current rules of conduct in force on the

internet (etiquette, code of conduct, etc.). Any person violating one or more of the articles in these rules will be banned from entering the competition, disqualified or denied any prize they may have won.

ARTICLE 4 - DETERMINING THE WINNERS

On Saturday 1st October 2022 at 9am, a draw will take place by Cotton Bird to determine which of the competition entrants is the overall winner (hereinafter referred to as the "Winner").

The Cotton Bird UK team will then contact the winning entrant via email using the address they indicated on the competition form. The competition winner must then contact Cotton Bird by email to confirm their win. The Organising Company will confirm the nature of the prize won as well has how to claim it. Any winner who fails to respond within 7 days of being informed of their win will be deemed to have forfeited their prize, which will then be attributed to another person.

ARTICLE 5 - DESCRIPTION AND ISSUING OF PRIZES

The following prize will be attributed to two winners:

In total, the prize has a commercial value of £665 including VAT. Prizes are valid with participating brands until 31st October 2022. The prize are for the person named and cannot be transferred or offered to any third party without the consent of Cotton Bird UKs' team. All three prizes will be attributed per winner (same name, same address). The winners must bear the cost of any further order or additional product desired by the winners and not included in the prizes. The prizes will be communicated to the winner by email as previously mentioned.

Cotton Bird can in no way be held responsible for the timescale involved in issuing the Prizes, or in the event that the Winner is unable to claim their Prize due to circumstances beyond the control of Cotton Bird. In particular, Cotton Bird can in no way be held responsible in the event of loss and/or damage to the Prize by the Post Office or by any other similar third party service provider, and more generally if the Winner does not receive their Prize. Cotton Bird may not, under any circumstances, be subject to any form of inquiry in the event of problems encountered regarding the issue and delivery of the Prizes.

Without prejudice to any legal action, Cotton Bird shall not be required to award any prize to the Beneficiary Entrant if the latter has obviously, and by any means, succeeded in distorting the result of the competition or has not complied with these Rules.

ARTICLE 6 – IDENTIFICATION OF WINNERS AND ELIMINATION

Entrants authorise the verification of their identity. Non-compliance with these rules as well as any fraud or attempted cheating, regardless of the methods used, will result in the pure and simple elimination of the author's entry.

Cotton Bird reserves the right to verify the age of any winner before awarding their prize. The prize may not under any circumstances be exchanged for its cash value or for any other prize. Cotton Bird shall not be held liable for the use or non-use, or even the trading, of the prize by the winner. In the event of force majeure, Cotton Bird reserves the right to replace the prize won with a prize of equivalent nature and value.

ARTICLE 7 - REIMBURSEMENT OF CONNECTION CHARGES

Internet connection or local call charges relating to entering the competition or online consultation of the rules will be reimbursed upon written request to the competition address, based on the cost of a local call - i.e. a flat rate of

£0.3. Entrants who do not pay connection charges based on the volume of their communication (people with an "unlimited" subscription, ADSL cable users, etc.) will not be reimbursed.

Costs relating to the request for reimbursement will be reimbursed on the basis of a simple letter weighing less than 20g and bearing a second class postage stamp.

ARTICLE 8 - DELIVERY OF PRIZES

By accepting the prize, the winner authorises Cotton Bird to use his or her surname, first name, postal address and internet address in any publicity or promotional event related to this Competition, without this use entitling them to any remuneration other than the prize won, for a maximum period of 2 years. Cotton Bird cannot be held liable for any delays, losses, damage, lack of legibility of the stamps caused by the postal services during delivery of the prizes. Prizes that are not claimed from the post office, or returned within 30 calendar days of dispatch, are deemed to be forfeited by the entrant and will remain the property of t Cotton Bird. The winners waive their right to claim from Cotton Bird any compensation resulting from a loss caused by the acceptance and/or use of the prize. CLAUSE 9 – AGREEMENT ON EVIDENCE

Except in the case of obvious errors, it is agreed that the information resulting from Editions Créatives' competition systems has evidential value in any dispute regarding the connection elements and the computer processing of the information relating to the Competition.

ARTICLE 10 – ATTRIBUTION OF JURISDICTION

Entrants are subject to French regulations applicable to games and competitions as Cotton Bird is a French company. Any dispute that cannot be settled amicably will be submitted to the competent courts designated in accordance with the French Code of Civil Procedure.

ARTICLE 11 - CONTROLS AND RESERVATIONS

Any entry that does not comply with the provisions of these rules will not be considered. In particular, the Cotton Bird reserves the right, in the event of force majeure, to shorten, extend, suspend, modify or cancel the Competition. Any such changes will, however, be notified in advance by all appropriate means. Cotton Bird cannot be held liable for any incident relating to network disturbances, the operation of the internet, in the event of any malfunction of the reception hardware preventing the proper running of the Competition, power cuts preventing an internet user from meeting the necessary conditions before the deadline, or more generally, for any incident beyond its control that would disrupt or prevent the Competition from running properly or internet users from entering the Competition.

Any dispute that may arise concerning the interpretation of these rules will be expressly submitted to Cotton Bird for judgement.

No disputes or claims will be considered after a period of one month following the end of the Competition – i.e. **4th November 2023 at 11.59pm**. No telephone enquiries relating to the terms and conditions of the Competition or the interpretation of these rules will be answered.

Entrants are hereby informed that, if they expressly agree, their personal data may be used for commercial offers by Editions Créatives and that they may object to such mailings at any time. Any request for access, rectification or opposition must be addressed to Editions Créatives.

ARTICLE 14 - MODIFICATIONS TO THE RULES

Cotton Bird reserves the right to modify at any time the articles of these Rules and in particular the rules of the competition and the Prizes awarded, essentially to take into account any changes to legal, regulatory or administrative provisions, judicial decisions, recommendations issued by the bodies in charge of running the internet network and Cotton Bird's business policy.

If one or more provisions of these Rules are declared null and void or inapplicable, the other provisions will retain their enforceability and scope. The competition is governed by French law. Entrants are therefore subject to French regulations applicable to competitions. Any dispute arising in connection with this competition and which cannot be settled amicably will be submitted to the competent courts.

ARTICLE 18 - ENTERING THE COMPETITION

You are entering a Competition organised by the Website. In legal terms this is called a contract. For direct marketing purposes, we may carry out profiling or decision-making, which cannot be carried out in a fully automated way. This operation is only conducted with your consent. Your data is intended for our marketing department, our sales department and our IT department. We make every effort to protect your personal data in accordance with European regulations. Your data is stored on servers. In this context, they may be transferred outside the European Union.

Your data will be deleted 3 years after the last contact.

ARTICLE 20 - FILING AND CONSULTATION OF THE RULES
